## 9. Terms & Conditions For Enrolment

- 1. All international students are required to pay an application / registration fee as per stated in related programme tuition fees schedule, which is non refundable, being the prepaid fee before the original approval letter is sent.
- 2. First year tuition fees is compulsory to be paid upon approval (VAL) given by Immigration.
- 3. For subsequent semester / term, full settlement of semester / term fees is required upon enrollment or by the start date of semester / term.
- 4. All payments are to be made in the form of bank draft, crossed cheque, telegraphic transfer or INTERNET banking to relevant Payee Name and bank account of INTERNATIONAL COLLEGE IMPERIA listed in the application form.
- 5. Fees paid are not refundable except in the circumstances set out below and provided that a request in writing for such refund is made to Finance:
  - (i) Application and EMGS fees are not refundable nor transferable.
  - (ii) Subject to paragraph (i) above, if student withdraws from a programme before the commencement
  - date of the semester / term, the refund of the prepaid fee would be considered and subject to approval
  - (iii) Subject to paragraph (i) above, if a student fails health screening test, Registration Fee and General Admin Fee are not refundable but the student is eligible for a pro-rated refund of tuition fees paid
- 6. All payment of refunds shall be made payable to the name of the parent / guardian / sponsor (if applicable), as specified in the Application Form.
- 7. All refunds whether of fees, deposits or any other payments shall be free of interest and shall be subject to the right of set-off by IMPERIA against any fees or whatsoever payments due and owning to INTERNATIONAL COLLEGE IMPERIA.
- 8. There shall be no refund (save and except refundable deposits) if a student is expelled from INTERNATIONAL COLLEGE IMPERIA due to academic misconduct or disciplinary behavior.
- 9. For all the remaining semesters / terms, all fees must be fully paid by the start date of semester / term. A late payment charge of RM 200 will imposed on the 2nd week of the semester, RM 300 for the 3rd week of the semester and RM 400 for the 4th week onwards of the semester / term.
